

# Software License & Terms of Use

This white paper sets out the terms on which **schemaforge** (the “Software”) is made available by Meridian Intelligence (“Meridian”). The Software is proprietary and confidential. It is **not open-source software**: it is licensed, not sold, for use only within a specific engagement, and must be removed once that engagement is complete. By receiving, installing, accessing, or using the Software, the recipient (“Recipient”) accepts these terms; no signature is required.

<b>LICENSE TYPE</b>	Proprietary; limited, non-exclusive, non-transferable, revocable. Owned by Meridian.
<b>PERMITTED USE</b>	Solely for the engagement for which the Software is provided (profiling or de-identifying the dataset made available for the engagement), for the term of that engagement.
<b>NOT PERMITTED</b>	Any other purpose, dataset, project, or production use; copying, distribution, modification, or reverse engineering.
<b>AFTER THE EXERCISE</b>	Delete and securely clear the Software and every copy from all systems within thirty (30) days.
<b>ACCEPTANCE</b>	Receiving or using the Software constitutes acceptance of these terms. No signature required.

## 1 NATURE OF THE LICENSE

The Software, including its source code, models, data files, and documentation, is the proprietary and confidential property of Meridian and its licensors. It is made available under a limited license and is not sold; no ownership interest passes to Recipient. This is not an open-source license and confers none of the rights associated with open-source software.

## 2 GRANT AND PURPOSE LIMITATION

Subject to the applicable engagement or agreement between the parties (the “Agreement”), Meridian grants Recipient a limited, non-exclusive, non-transferable, non-sublicensable, revocable license to install and use the Software **solely for the specific engagement, task, and purpose for which it is provided** (the “Purpose”), in the authorized environment, and only for as long as that engagement is in effect. Use for any other purpose — a different dataset, a different project, ongoing production use, or internal reuse after the engagement — is outside this license and is not permitted.

## 3 RESTRICTIONS

Except as expressly permitted, Recipient shall not, and shall not allow any third party to:

1. use the Software beyond the Purpose, term, users, or environment authorized by the Agreement;
2. copy, distribute, publish, disclose, sell, rent, lend, or host the Software, or otherwise make it available to any third party;
3. modify, adapt, or create derivative works of the Software;
4. reverse engineer, decompile, or disassemble the Software, except to the narrow extent that restriction is unenforceable under applicable law;

5. remove or obscure any proprietary or confidentiality notice; or
6. use the Software, or know-how in it, to build or train a competing product.

#### 4 CONFIDENTIALITY

The Software is Meridian's Confidential Information. Recipient shall protect it with at least reasonable care and limit access to personnel who require it for the Purpose and who are bound by confidentiality obligations at least as protective as these.

#### 5 DELETION AND CLEARANCE AFTER THE EXERCISE

On completion of the Purpose, or on any termination of this license, Recipient shall promptly and no later than **thirty (30) days** thereafter: (i) cease all use of the Software; (ii) **permanently delete and securely clear the Software and every copy** — all installations, build artifacts, containers, images, and derivatives — from every system, device, environment, and backup within its possession or control; and (iii) certify that deletion and clearance to Meridian in writing on request. Nothing derived from the Software may be retained after the exercise.

#### 6 WARRANTIES AND LIABILITY

THE SOFTWARE IS PROVIDED "AS IS," WITHOUT WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT. TO THE MAXIMUM EXTENT PERMITTED BY LAW, MERIDIAN SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR EXEMPLARY DAMAGES ARISING OUT OF OR RELATED TO THE SOFTWARE OR THESE TERMS.

#### 7 TERM, TERMINATION, AND GENERAL

This license takes effect on delivery of the Software and terminates automatically on completion of the Purpose, on expiry or termination of the Agreement, or on any breach. The ownership, restriction, confidentiality, and deletion obligations survive termination. If these terms conflict with the Agreement, the Agreement governs, and nothing here grants any right beyond it. This license is governed by the law specified in the Agreement, may not be assigned without Meridian's prior written consent, and remains in effect as to its other provisions if any provision is held unenforceable. The controlling terms are set out in the LICENSE file distributed with the Software.
