

AI SQUARED DEVELOPER LICENSE AGREEMENT

READ THIS LICENSE AGREEMENT ("AGREEMENT") CAREFULLY BEFORE DOWNLOADING, INSTALLING, ACCESSING, COPYING OR USING THE SOFTWARE AND RELATED DOCUMENTATION WITH WHICH THIS AGREEMENT IS ASSOCIATED. CLICKING ON THE "ACCEPT" BUTTON BELOW, OR DOWNLOADING, INSTALLING, ACCESSING, COPYING OR USING THE SOFTWARE, CREATES A BINDING CONTRACT BETWEEN AI SQUARED, INC. ("AI SQUARED") AND YOU (TOGETHER WITH THE BUSINESS OR OTHER ENTITY FOR WHICH THE SOFTWARE IS OBTAINED, "YOU") AND CONSTITUTES ACCEPTANCE OF ALL TERMS AND CONDITIONS OF THIS AGREEMENT WITHOUT MODIFICATION.

IF YOU ARE NOT AUTHORIZED TO ENTER INTO THIS AGREEMENT, OR IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, THEN YOU MUST CLICK ON THE "CANCEL" BUTTON BELOW AND YOU MAY NOT DOWNLOAD, INSTALL, ACCESS, COPY OR USE THE SOFTWARE.

1. GRANT. Subject to the terms of this Agreement, AI Squared grants to You a limited, personal, nonexclusive, non-sublicensable, nontransferable, royalty-free license to use the AI Squared Python Software Development Kit (including without limitation, the documentation, software libraries, binary executables, packaged APIs, code samples, web applications, scripts, software development tools, validation processes, and source code, in the form and format provided by AI Squared ("Software") internally, and solely for the purpose of internally evaluating, creating integrations with, developing and demonstrating applications, products, services and any other software or hardware applications that are interoperable with AI Squared's machine learning platform (the "Platform"). You may use, copy and modify the Software as reasonably necessary to support Your internal use and your integration with the Platform. For clarity, the foregoing license does not grant to You any right or license to commercialize, distribute or use the Software or any product or service developed using the Software in a commercial or production environment other than strictly for non-commercial evaluation, development and demonstration purposes. In the event that You wish to commercialize a product that is interoperable with the Platform, You need to contact AI Squared and enter into a separate commercialization agreement. Except for the limited rights and license expressly granted hereunder, no other license is granted, no other use is permitted and AI Squared (and its licensors) shall retain all right, title and interest in and to the Software (and all intellectual property and proprietary rights embodied therein).

2. SUPPORT. AI Squared may, in its discretion, but shall have no obligation under this Agreement, to provide You with any technical support or other maintenance services. If AI Squared provides You with any upgrade, patch, enhancement or other version of the Software, it shall be deemed part of the Software and subject to this Agreement. At its discretion, AI Squared may make any such support and maintenance services available to You for a fee.

3. RESTRICTIONS. Except as specifically permitted in Section 1 of this Agreement, You shall not directly or indirectly (a) use the Software or any product or service developed using the Software for any commercial purpose without a separate license and services agreement with AI Squared for such use, (b) publish, disclose or disseminate any information concerning any comparisons or other "benchmarking" activities in respect of the Software or the Platform, (c) distribute, transmit or provide the Software or any product or service to any third party, (d) use the Software in violation of any applicable laws or regulations, including but not limited to, laws regarding personal data, privacy, intellectual property, trade secrets, copyright and export controls, (e) remove any proprietary notices from the Software, or (f) permit any third party to engage in any of the foregoing proscribed acts.

4. CONFIDENTIALITY. You acknowledge that the Software and related documentation and other information that You may receive from AI Squared is the confidential or proprietary technical and business information of AI Squared, including without limitation any source code, code samples, libraries, and validation processes provided in connection with the Software ("Confidential Information"). You shall: (a) hold and maintain in strict confidence all Confidential Information; and (b) not use any Confidential Information except as permitted by this Agreement or as may be necessary to exercise rights or perform obligations under this Agreement. You shall use at least the same degree of care to protect the Confidential Information as used to protect Your own Confidential Information of like importance, and in no event shall such degree of care be less than reasonable care. The foregoing restrictions on disclosure and use shall not apply with respect to any Confidential Information which (i) at the time of disclosure is publicly available or becomes publicly available through no act or omission by You; (ii) You independently develop, provided that that such development was accomplished without the use of or any reference to the Confidential Information; or (iii) becomes known to You from another source without confidentiality restriction on subsequent disclosure or use. You agree that the harm suffered by AI Squared would not be compensable by monetary damages alone and, accordingly, that AI Squared shall, in addition to other available legal or equitable remedies, be entitled to injunctive or other equitable relief against such breach. To the minimum extent possible, You may use or disclosure confidential information

as required by court order or as otherwise required by law, on condition that notice of such requirement by law for such disclosure is given to AI Squared prior to making any such use or disclosure.

5. INDEMNITY. You agree (a) that AI Squared shall have no liability whatsoever for Your use of the Software or any use of the Platform, and (b) to indemnify and hold harmless AI Squared from all damages, liabilities, losses, costs, and expenses (including attorneys' fees) arising from claims related to Your use of the Software or any use of the Platform.

6. WARRANTY DISCLAIMER. THE SOFTWARE IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND. AI SQUARED DOES NOT WARRANT THAT THE SOFTWARE OR ACCESS TO THE PLATFORM WILL MEET YOUR REQUIREMENTS OR THAT THEIR OPERATION WILL BE UNINTERRUPTED OR ERROR-FREE. TO THE FULLEST EXTENT PERMITTED BY LAW, AI SQUARED AND ITS LICENSORS HEREBY DISCLAIM ALL WARRANTIES, WHETHER EXPRESS OR IMPLIED, ORAL OR WRITTEN, WITH RESPECT TO THE SOFTWARE AND PLATFORM INCLUDING, WITHOUT LIMITATION, ALL IMPLIED WARRANTIES OF TITLE, NON-INFRINGEMENT, QUIET ENJOYMENT, ACCURACY, INTEGRATION, MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE AND ALL WARRANTIES ARISING FROM ANY COURSE OF DEALING, COURSE OF PERFORMANCE OR USAGE OF TRADE.

IN NO EVENT SHALL AI SQUARED OR ITS LICENSORS BE LIABLE TO YOU OR ANY OTHER PERSON CONCERNING THE SUBJECT MATTER OF THIS AGREEMENT, REGARDLESS OF THE FORM OF ANY CLAIM OR ACTION (WHETHER IN CONTRACT, NEGLIGENCE, STRICT LIABILITY, TORT OR OTHERWISE), FOR ANY DIRECT, INDIRECT, PUNITIVE, INCIDENTAL, RELIANCE, SPECIAL, EXEMPLARY OR CONSEQUENTIAL DAMAGES OF ANY CHARACTER INCLUDING, BUT NOT LIMITED TO, LOSS OF DATA, BUSINESS, REVENUES, PROFITS OR GOODWILL, WORK STOPPAGE, ACCURACY OF RESULTS, COMPUTER FAILURE OR MALFUNCTION, OR ANY OTHER DAMAGES RESULTING FROM YOUR USE OF THE SOFTWARE.

8. TERM. This Agreement shall commence on the date of Your acceptance of its terms, and continue in effect until terminated as provided herein. You may terminate this Agreement (including the license granted herein) at any time by stopping all use of the Software. This Agreement (including the license granted herein) shall terminate automatically, without further action by any party, immediately upon Your breach of any provision of this Agreement. AI Squared may terminate this Agreement at any time upon notice to You. Upon any termination of this Agreement, You shall destroy all tangible copies of the Software and permanently erase all copies of the Software (in whole or in part) contained in any computer or storage media and removing any code from any software with which the Software was integrated, embedded or used. Sections 3 through 10 shall survive termination of this Agreement.

9. MISCELLANEOUS. You hereby consent to inclusion of Your organization's name in customer listings that may be published as part of AI Squared's marketing efforts. If any provision of this Agreement is found to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that this Agreement shall otherwise remain in full force and effect and enforceable. This Agreement is not assignable, transferable or sub-licensable by You except with AI Squared's prior written consent. This Agreement is the complete and exclusive statement of the mutual understanding of the parties and supersedes and cancels all previous written and oral agreements, communications and other understandings relating to the subject matter of this Agreement, and that all waivers and modifications must be in a writing signed by both parties, except as otherwise provided herein. No agency, partnership, joint venture, or employment is created as a result of this Agreement. In any action or proceeding to enforce rights under this Agreement, the prevailing party shall be entitled to recover costs and attorneys' fees. All notices under this Agreement shall be in writing, in English and shall be deemed to have been duly given when receipt is electronically confirmed, if transmitted by e-mail sent to the account used to register for the Software or in the case of AI Squared to legal@squared.ai. Neither party shall be liable for any loss resulting from a cause beyond its reasonable control. This Agreement shall be governed by the laws of the State of New York, U.S.A. without regard to its conflict of laws provisions. The federal and state courts sitting in the New York, New York, U.S.A. shall have proper and exclusive jurisdiction and venue with respect to any disputes arising from or related to the subject matter of this Agreement.
